GIFT AID

Increase the value of your payments to the Association at no cost to yourself.

Gift Aid is a scheme that allows charities and eligible clubs to claim from HMRC the basic rate of tax that their donors have paid. Gift Aid increases the value of membership subscriptions and donations by 25% without costing you any extra.

Making a Gift Aid declaration gives us permission to claim back 25p for each £1 that you donate or subscribe as a member to the Association and your donations and subscriptions will qualify if you have paid at least as much in Income Tax or Capital Gains Tax in that tax year as the Association will claim in Gift Aid.

If you stop paying enough tax to qualify for Gift Aid, please let us know. If you don't let us know, and you pay less tax in the tax year than the amount of Gift Aid claimed, you may be required to pay any difference back to HMRC.

The arrangement will apply to any subscription or donation payments that you make and will continue to apply until you notify us that you wish to cancel your declaration. If you have any queries or need further information about this, please contact us.
